## CREDIT STATUS

Northwest Florida State College's Concurrent Enrollment program provides the opportunity for qualified high school students from Okaloosa and Walton Counties, who meet the specified eligibility criteria, to enroll in certain college courses while simultaneously enrolled in a public, private or home school. College credits earned through concurrent enrollment, unlike dual enrollment do not apply to a student's high school diploma. Students concurrently enrolled pay all registration, laboratory and tuition fees; and are also responsible for purchasing all textbooks.

**ELIGIBILITY REQUIREMENTS:**

Students must:

- Be a high school student (grades 10 through 12).
- Receive the acknowledgement from their high school that they are in good standing and have a minimum unweighted 3.00 GPA.
- Have permission of principal (or home school provider), parent and the approval of the college.
- Take a State approved placement test (ACT, SAT, FCPT) if enrolling in any college credit course 3 semester hours or more, and pass all appropriate subtests if enrolling in a college English, math, reading, Gordon rule social science, or humanities course, or any course which requires English, math or reading prerequisites.
- Have a sincere interest in and a strong aptitude for the subject matter in the college course(s) selected.
- Comply with all the rules and regulations of the college and maintain a "C" average or better on all college work. Substandard academic performance at the college or failure to comply with college rules and policies will result in the enforced withdrawal of the student from the program. Enrollment in the college shall in no way jeopardize completion of regular high school work.
- Restrict enrollment at the college to part-time status – no more than 11 credits per term.
- Enroll for a grade (credit status) or for audit.
- **IF AUDITING, enroll on a Space-Available-Basis, no earlier than the first day of classes.**
- If a home-schooled student, a copy of your current signed and updated *Legal Compliance and Eligibility Form* (proof of enrollment in a home school program) that is on file with your school district must be submitted to NWFSC at the time of registration.

**PLACEMENT TEST SCORES:** No high school concurrent enrollment student shall be enrolled in a college mathematics, English, reading, Gordon Rule social science or humanities course unless the student has demonstrated adequate pre-collegiate preparation on the basic mathematics and communication skills assessment of an approved entry-level placement test. **Minimum acceptable scores for the currently administered placement tests are listed below.**
