- On Facilities, the college is finishing up the College Police Department renovations.
- The old ROTC building is being renovated to house Softball Offices and other needed space for the Team.
- Student Affairs along with IT has launched "Degree Works" which will allow students access to review their degree programs, etc.
- Student Affairs staff are visiting local high schools and admitting and registering students on site.

- The Summer/Fall Registration is underway at this point.
 We are capturing students before the semester ends to sign them up for both summer and fall classes.
- On May 20th, I will present to the State Board of Education the College's 2nd report associated with our Improvement Plan.

In order to apply for TRIUMP dollars the agencies must partnership with an educational institution; thereby, we are getting invites to participate – but it will be up to the college on which ones we feel works in our college mission.
