Public Comments

Nathan Sparks, Executive Director, Economic Development Council – Okaloosa County pledged his support for NWFSC's Airframe and Powerplant Program to be housed at the Crestview Technology Air Park (CTAP), calling it a catalyst for the advancement of the aerospace community in our region.

Commissioner Carolyn Ketchel affirmed NWFSC's mission to improve the lives of residents of Okaloosa County and as a member of the Okaloosa Aviation Board expressed her excitement to see the addition of Airframe and Powerplant programming as an opportunity for training for our community's transitioning veterans.

Tracy Stage, Director of Okaloosa Airports, believes this partnership between NWFSC and CTAP can provide a pipeline of opportunity not only for students but also for business and industry looking to locate themselves in Okaloosa County. He announced that the Okaloosa Aviation Board is committing \$625,000 to build a parking lot for faculty, staff and students in the Airframe and Powerplant program at the CTAP site.

Dr. Paul Hsu thanked the NWFSC Board of Trustees for considering this partnership to bring Airframe and Powerplant programing to CTAP, vowing it will have a long-lasting impact on Okaloosa County.

Amanda Negron applauded NWFSC's proactive stance to prepare and usher young students toward high tech educational programs for many years to come and thanked senior college leadership for the opportunity to enter into a memorandum of agreement with the Hsu Educational Foundation.
