C. INSTRUCTIONS FOR TAX RETURN FILERS: Please read to understand your two choices.

1. Using the **IRS Data Retrieval Tool in FAFSA on the Web** is the preferred way to verify income. If you have not already used the tool, go to FAFSA.gov, log into to your FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. Follow the instructions to determine if you are eligible to use the IRS Data Retrieval Tool to transfer 2015 IRS income tax information into your FAFSA. It takes up to two weeks for IRS income information to be available for the IRS Data Retrieval Tool for electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers. If you need more information about when or how to use the IRS Data Retrieval Tool see your financial aid administrator.

If your parents are married and they filed separate 2015 tax returns, you must submit tax returns transcripts for both of your parents.
