

ALABAMA RESIDENCY CLASSIFICATION

REQUEST FOR ALABAMA DIFFERENTIAL OUT-OF-STATE TUITION

The Florida legislature allows the option of providing Alabama residents a different tuition assessment for post-secondary classes. At NWFSC, the Alabama Border State Fee, at a rate of an additional \$1.00 per credit hour to the current in-state tuition rate, will be assessed for all eligible Alabama residents.

To be eligible for the Alabama Border State Fee, the student must complete the Alabama Residency Form and meet all criteria as stipulated on the form, including a current Alabama residence (permanent address) and proof of Alabama residency. Additional documentation, other than what is specifically listed, may be required.
