KIDS ON CAMPUS WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission to be on the premises of Northwest Florida State College and Volunteer for Kids on Campus, on June 23 – July 2 and/or July 12 – 16, 2021, I hereby acknowledge and agree to the following for _____, who will be Volunteering:

1. I understand the hazards of the novel coronavirus (“COVID-19”) and am familiar with the Centers for Disease Control and Prevention (“CDC”) guidelines regarding COVID-19. I acknowledge and understand that that the circumstances regarding COVID-19 are changing from day to day and that, accordingly, the CDC guidelines are regularly modified and updated and I accept full responsibility for familiarizing myself with the most recent updates.
2. I understand that volunteering for the Kids on Campus program may require that my child, as a volunteer, may violate the social distancing guidelines established by the CDC by being within 6 feet of other students or instructors and being in groups of 10 or more. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to have my child volunteer and participate in Kids on Campus for which my child has submitted and acknowledged the volunteer application.
3. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my child volunteering on the premises and participating in Kids on Campus and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, Northwest Florida State College, their officers, directors, employees, and assigns (the “RELEASEES”) from any liability related to COVID-19 which might occur as a result my child’s volunteer time and participation in the Kids on Campus program.
4. I shall indemnify, defend and hold harmless the RELEASEES from and against any and all claims, demands, suits, judgments, losses or expenses of any nature whatsoever (including, without limitation, attorneys’ fees, costs and disbursements, whether of in-house or outside counsel and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.

IN SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Wavier of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Agreement for full, adequate and complete consideration fully intending to be bound by same.
