APPLICATION PROCESS

The application process is complete when the following items are on file in the Fine & Performing Arts Division office:

1. **Completed, scholarship application form.** Please neatly fill this form out in blue or black ink. You may type the form.
2. **Verification of applicant's cumulative GPA (Guidance Counselor's form).** If you have completed a semester or more of college outside of high school, please leave page 3 blank.
3. **Letters of recommendation.** "Letter of Recommendation" forms are attached to facilitate this process.
4. **Participate in the vocal audition. This audition will consist of three parts.**
 - i. **Solo Vocals:** Vocalists must be prepared to perform two (2) contrasting pieces from memory. One may be in a foreign language. You may also choose two contrasting pieces from appropriate musical theatre repertoire. *You may use musical accompaniment on your phone and an AUX cable will be provided to play from our system. If you wish to have piano accompaniment, please turn in sheet music with your application.*
 - ii. **Music Theory Placement Test:** A two-page written theory test to assess what level of Music Theory courses to place you in. *This will not affect your chances of receiving a scholarship.*
 - iii. **Group Vocals:** Vocalists may be asked to participate in a group callback to hear vocalists perform in a group setting. This will allow for directors to test blending, vocal placements, and learning capabilities. *Vocalists do not need to prepare anything for this portion of the audition.*
 - iv. **Audition Date: Saturday, April 8, 2023, at 1:30 pm in Tyler Recital Hall.**
